** Tuition is an annual tuition paid in **10** equal installments. The first installment is due **June 1, and is non-refundable**. Subsequent installments are due on the first of each month, September through May. EDC is paid in **9** equal installments (September through May), no reduction will be allowed for months with fewer days. Minimum days are included in the monthly fee. NO charge on early out Wednesday's from 2:00 pm to 3:00 pm.

TUITION POLICY

General Terms and Conditions

1. Students will not be permitted to attend class if their tuition is more than 30 days delinquent.
2. Parents must meet their financial responsibilities promptly in order to maintain teacher salaries and school expenses.
3. A \$25.00 service charge will be assessed for returned checks. Cash payments will be required if more than one check is returned by the bank due to insufficient funds.
4. Payments may be made in 10 equal installments. The first installment is due June 1 and is non-refundable. Subsequent installments are due on the first of each month, September through May.
5. All registration fees are non-refundable.
6. **LACS considers enrollment a commitment for the entire school year and bases all budgetary decisions on this assumption. When a student is voluntarily withdrawn from the school *for any reason*, tuition must be paid in full for each calendar month that the student was in attendance on the basis of the 1/10th of the annual tuition. A WRITTEN NOTICE one month in advance MUST be given to the registrar. If the parent withdraws the student in the middle of a month, the tuition for that month will not be prorated. Failure to give one month's written notice will result in a penalty of an additional month's tuition.**
7. If a child attends through the ninth month, or any part of the ninth month, of the ten school months, the full tenth month tuition will be due to the school.
8. A 10% late charge will be assessed if the payment is not received by the tenth of the month.
9. Illnesses and vacations are not deductible from tuition.
10. The second child tuition rate does not apply to LAD, Middle School, or Kinder Prep tuition.
11. Equal Monthly **EDC** Payments – As this schedule is based on an annual fee that has been divided into **nine** equal monthly payments, no reduction will be allowed for months with fewer days. Minimum days are included in the monthly fee.
12. Partial EDC hours – **Any part of an hour will be counted as a full hour.**
13. Before and after school hours – **Students who arrive before 8:10 AM or remain after 3:15 PM will be sent to Extended Day Care and charged the appropriate fees.**
14. **Late pick-up fee** – Anyone picking up his or her child **after 6:00 PM** will be charged \$1.00 for each minute overtime.
15. **School Holidays** -- Extended Day Care will **not** be available on any school holiday or vacation period.
